**Booth Space** – We will provide the Vendor with choice of indoor or outdoor space measured off at 8' x 10' per booth. We have a limited number of tables for those booking a space with table at \$30 each. All booth spaces will receive a folding chair.

**Electricity** – We have limited electricity available at an additional cost. Please make your selection accordingly and add \$10 to the total due.

**Set Up** – Doors will open at 9:00 am on Friday April 5<sup>th</sup>, 2019 and remain open until 7:00 pm for the Vendor to set-up their booth. Access for set-up will also be available at 7:00 am on Saturday April 6<sup>th</sup>, 2019 prior to the doors opening at 9:00 am for the event.

**Tear Down** - Tear down is Sunday April 7<sup>th</sup>, 2019 at 3:00 pm and not before. Vendors who tear down prior to 3:00 pm risk not being permitted to participate in future years. We will be on site for tear down until 8:00 pm on Sunday evening to allow Vendors the opportunity to pack up and clear out.

**Refunds** – While we understand that things happen and you may pay for space and not be able to attend after submitting payment and contract, however we will not offer any refunds.

**Accidents** – The Williams County Agricultural Society Directors and Volunteers assume no responsibility for accidents or damages. It is the responsibility of the Vendor to protect their materials and items to prevent damages and or theft. It is highly recommended your booth display a sign clarifying that you are not responsible for accidents.

**Validity** – In order to better serve all Vendors who wish to attend, you must sign and return the contract with payment by March 15<sup>th</sup>, 2019. Unsigned or incomplete payment will be cause to exclude your contract from the event.

**Payment** – The Williams County Agricultural Society will accept payment for contracts via cash, check (made payable to the Williams Co. Ag. Society) and credit card payments. Credit Card payments do have a **convenience fee** that we add to the total purchase authorized on the card.
