Pass is valued at \$118 and would be sold at \$80. The pass will be sold only in the office until Labor Day. Motion By: Henricks moves to accept the VIP Pass as presented. Page seconded the motion. Voice Vote motion passed.
- 4) Golf Cart / UTV Pass It was shared with the Board the concept of selling the UTV/Golf Cart pass at a rate of \$25.00. The pass would allow for easier movement for those registered. Motion By: Henricks moves to accept the Golf Cart/UTV Pass as presented. Carroll seconded the motion. Voice Vote – motion passed.

- 5) Shower Trailer Page presented an option from OFMA to bring in a shower trailer for the campgrounds. The cost is \$2500 for the week with the unit having 2 for men and 2 for women. There are also additional costs for the Board to have the unit pumped each day. Following discussion, Motion By: Wilson to table the topic. Tom Fry seconded the motion. Voice Vote motion passed.
- 6) Grandstand Box Seats Kennedy presented the option of using the crows nest for BOX seating at a rate of \$100 each with seating comfortable for 8 people. Motion By: Bennett to accept the Box Seating at \$100 for the Demo. Wortkoetter seconded the motion. Voice Vote motion passed.
- 7) Committee Budgets Kennedy announced that all committee budgets are due by February 4th at 7:00 p.m.
